be replaced, and an ash tree is covering up the sign itself. No further suggestions were made in addition to those from last month's meeting. Cllr. Carty summarised some recent correspondence from Mike Rigby of Somerset Council regarding the Pinford Lane DMMO application and Somerset Council's interest in routes for Active Travel or any Local Walking & Cycling Improvement Plan.

Action: Cllr. Tizzard will make some enquiries regarding the ash tree next to the sign.

Verbal Updates / Reports:

(a) Update on Previous Planning Applications: None.

(b) Update on Current Live Housing Development Applications

I. **Messrs Parker, Davis and White, Wheathill Lane:** No further news.

II. **Burrington, Court Lane:** Cllr. Carty reported that the Campaign for the Protection of Rural England have expressed concerns about the Court Lane hedgerow and banking (south side) in relation to the Court Lane and Wessex Water applications, but Somerset Council's tree officer, Phil Poulton, is on balance not overly concerned, so there will be no preservation order on it. Cllr. Capon added that permission will still be required to do any work on the hedge; Court Lane is an ancient holloway. There was some discussion about the relative advantages or disadvantages of removing trees and replanting in relation to development.

Wessex Water have disputed some of the calculations made by Lead Local Flood Authorities.

III. **Other recent news/information:** None

(c) Update on Construction Management of Active Sites: Cllr. Watts reported that the Redcliffe site contractors have rotovated, tidied and seeded the area where shop and hub are due to go.

Update on Highways Issues (incl. speeding): There has been no news regarding the island crossing installation at Crackmore.

Meeting Ended at 8pm

Cllr. Carty canvassed opinion about whether members approve of the funding (£126) by the Office of the printing of bus timetables (to be inserted into copies of the November Village Magazine) as part of the Bus It campaign to increase bus usage and reduce the risk of a reduction or loss of services on the Yeovil-Wincanton route. All were in agreement that this expenditure should be made. Cllr. Phillips suggested that the website *bustimes.org* be included in the information.

Cllr. Carty encouraged members to attend the online Gigaclear 'drop-in' which is apparently scheduled for on 6 November 7pm to 8pm, although it is not yet featured on their website.
